

PRIVACY STATEMENT

On the protection of personal data collected by EUROCONTROL through the 8.33kHz VCS GA website (www.833radio.com)

EUROCONTROL protects your personal data in accordance with the [EUROCONTROL Regulation on Personal Data Protection](#) of 28/12/2006 adopted by its Member States.

1. Why do we collect, store and process your data?

The 8.33kHz VCS GA website (www.833radio.com) is an information resource on radio equipment, mandates and funding opportunities for General Aviation operating in the European airspace. In this context, your data is collected and stored to enable the creation of a unique airborne radio equipage European database and provide you with specific information regarding 8.33 equipage requirements, incentives and funding opportunities. The data is also stored for statistical purposes.

2. What personal data do we collect, store and process?

We collect the data directly from you when you register on the web-site.

The personal data we collect is divided in the following subsets:

- "User Profile mandatory data": This personal data allows us to identify you as a user and contains: First Name, Last Name, Email and Preferred language
- "User profile additional data": this allows us to have more information about you and contains: Company name, Phone, association name if you are a member of an e.g. aero club and the Country.
- "News feed data" which allows us to target specific news and information adapted to your profile and preferences
- "Aircraft mandatory data", containing the Country of registration, aircraft registration, aircraft make, model and type, operating rules and category
- "Aircraft additional data" containing: the 24bit address and the Country of operation (i.e. the country in which the aircraft is mostly used).
- "Radio equipment details" containing, the radio make, model and series, date of manufacture, channel spacing capability and if the equipment is installed in the airframe or not

3. Who is your data disclosed to? Who has access to your data?

The collected data will be treated confidentially and used only by the relevant staff of the EUROCONTROL 8.33VCS implementation support project.

4. How long is your data kept?

Data is kept as long as you keep your 8.33kHz VCS GA website user account active. When you close your account, your personal data is deleted.

5. How can you access your data, check its accuracy and, if needed, correct it?

It is possible to access and update your data using self-service interfaces (i.e. online tool function to edit your profile) and the update is immediate. You may also delete all your personal information, including the aircraft registered and its details. This means that you will also terminate all services and access rights that may be linked to this information (e.g. information dissemination).

6. What do we do to avoid misuse or unauthorised access?

EUROCONTROL is committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure EUROCONTROL has put in place suitable physical, electronic and managerial procedures to safeguard and secure the information collected online.

7. Who is responsible for the processing of your data (“Controller”)?

The processing of your data is managed by the Project Manager of EUROCONTROL 8.33VCS Implementation Support project team, Bogdan Petricel.
